

REALLOCATION CHEAT SHEET

FY 2025 CoC NOFO (FR-6900-N-25)

PLEASE NOTE: The RNCOC does not have any YHDP or DV Renewal projects

WHAT IS “REALLOCATION”?

- CoC tool to shift funds from existing eligible renewal projects (in whole or part) into new projects, without reducing ARD.
- Source projects must:
 - Have an executed grant agreement, **and**
 - Expire in Calendar Year 2026 (Jan 1–Dec 31, 2026).
- New projects created with reallocation must meet project eligibility and quality thresholds in the NOFO.
- HUD expects CoCs to reallocate from lower-performing to higher-performing projects and scores CoCs on having/using a reallocation process.

FLOWCHART – “CAN THIS PROJECT BE REALLOCATED?”

STEP 1: Is this an executed renewal grant expiring in CY 2026?

- **No** → **✗** *Not eligible for reallocation under FY 2025 CoC NOFO.*
- **Yes** → go to Step 2.

STEP 2: What type of renewal is it?

- **Standard CoC / Special NOFO Unsheltered-Rural (non-DV)** → go to Step 3.
- **DV Renewal** → go to Step 4.
- **YHDP Renewal** → go to Step 5.

STEP 3 – Standard CoC/Special NOFO Renewals (non-DV)

3A. Can we reduce or eliminate it (whole or part)?

If yes, dollars can be reallocated.

3B. What can we create?

Using CoC Reallocation / CoC Bonus, you may create new:

- SSO
- TH
- PH-PSH
- PH-RRH
- HMIS (HMIS Lead only, including comparable DB for VSPs)
- SSO-CE

3C. Special options *(Not allowed for DV renewals or YHDP renewals)*

- **Expansion project:** Add funds (via reallocation/Bonus) to expand the same component as the renewal.
- **Transition grant:**
 - One or more renewals are fully eliminated.
 - All of those funds go to *one* new project with a different component.
 - Project must fully transition to the new component by the end of the 1-year term.

STEP 4 – DV Renewals

4A. Is the DV renewal SSO-CE only?

- **Yes** → **✗** *Cannot be reallocated.* It may renew as-is; CoC can also apply for DV Bonus for additional DV projects.
- **No** → go to **4B**.

4B. DV Reallocation rules

- DV Renewal dollars may only create DV-dedicated projects serving survivors fleeing/attempting to flee DV, dating violence, sexual assault, or stalking who meet homelessness criteria.
- Allowed new components with DV Reallocation/DV Bonus:
 - DV TH
 - DV PH-RRH
 - DV SSO-CE

4C. DV “NOs”

- **✗** Cannot create non-DV projects.
- **✗** Cannot use DV dollars to expand non-DV CoC or YHDP projects.
- **✗** Cannot use the transition grant process.

STEP 5 – YHDP Renewals

5A. YHDP-specific options (must remain youth-focused):

- **YHDP Replacement:** Replace the renewal with a new youth project with the same recipient.
- **YHDP Reallocation:** Reallocate funding to a new youth project and recipient.
- **YHDP Expansion:** Expand via the YHDP replacement/reallocation process.

5B. YHDP “NOs”

- **✗** Cannot consolidate or mix YHDP funds with non-YHDP projects.
- **✗** UFAs cannot move funds into or out of YHDP projects (beyond allowed replacement).
- **✗** YHDP Renewals cannot use transition grants.

Standard CoC Renewal (PSH, RRH, TH, SSO, HMIS, non-DV)	New SSO, TH, PH-PSH, PH-RRH, HMIS (HMIS Lead), SSO-CE via CoC Reallocation/Bonus; expansions of same- component renewals; transition grant using full elimination of one or more renewals → one new component	Cannot reduce ARD overall; new projects must meet eligibility & quality thresholds; mis-labeled “reallocation” without valid source may be reduced/rejected
Special NOFO Unsheltered/Rural Renewal (now a CoC renewal)	Same as Standard CoC Renewal (if expiring in CY 2026)	Same limits as above
DV Renewal (non-SSO- CE)	DV Reallocation/DV Bonus to create DV TH, DV PH-RRH, DV SSO-CE; may expand DV-dedicated projects	Cannot create non-DV projects; cannot expand CoC or YHDP projects; cannot use transition grants
DV Renewal SSO-CE-only	Renew SSO-CE; CoC can apply for separate DV Bonus for new DV projects	Cannot be reallocated; DV funds cannot expand non-DV projects
YHDP Renewal	YHDP Replacement/Reallocation/Expansion for youth projects only (same or new recipient)	No mixing with non-YHDP; UFAs can’t move funds in/out except via replacement; cannot use transition grants
HMIS Renewal (HMIS Lead)	Can be reduced to free dollars for other eligible new projects; can be expanded via reallocation/Bonus for HMIS/comparable DB	New HMIS projects must be HMIS Lead; non-HMIS recipients can’t create HMIS projects; activities must remain HMIS/comparable DB
Ineligible Renewal (no executed grant or not expiring in CY 2026)	None	Cannot be used for renewal, reallocation, or replacement; HUD will remove from ARD
